July 8, 2024 MONTHLY TOWN BOARD MEETING FOR TOWN OF FRANKLIN

The July monthly meeting for the Town of Franklin was called to order at 7:00pm by Chairman Wesely following the Pledge of Allegiance.

Officers present: Dave Wesely, Lori Kleiman, Katie Duckart, Sandy Smidle & Suzi Sevcik.

Supervisor Duckart made a motion to approve the agenda, Supervisor Kleiman seconded the motion. Motion carried.

Supervisor Kleiman made a motion to accept the minutes from the June Town Board meeting. Supervisor Duckart seconded the motion. Motion carried.

Treasurer Sandy Smidle presented the Treasurer's Report, which shows a balance of \$280,142.87 Supervisor Duckart made a motion to accept the Treasurer's Report, Chairman Wesely seconded the motion, motion carried.

In matters from visitors, Ryan Maigatter inquired about keeping a portion of a structure up that had once been a house to preserve the historic value of a log home, he'll meet with the zoning administrator to review the plans as he also wants to build a house there and the condition was the existing house had to come down.

Zoning administrator Suzi Sevcik noted there were 3 building permits issued, and an inquiry about land division between property owners, for that only a CSM and board approval of the CSM would be required.

First Responder Suzi Sevcik reported that they received a large donation from Kate & Doug Elwell as well as a donation from Jane Seidl as well.

Roadwork update -

- Ditches are cut
- Drumm Rd is graded & extra gravel added price came in on budget
- Scotts will be doing paving at the end of July, Seal Coat in August
- Culverts Pre inspection is almost complete

The Joy Konop/Copper Top rezone was discussed and without the 4 items the planning commission required, Supervisor Duckart made a motion to table the request until the needed documentation was done. Chairman Wesely seconded the motion. Motion carried.

The Stangelville Inn has applied for a liquor license. Clerk Sevcik noted that all the paperwork was in order, the fee for the Reserve License was paid (\$10,000) in addition to the regular license fee. It was also properly noticed in the Denmark News. Chairman Wesely made a motion to approve the liquor license, Supervisor Kleiman seconded the motion, motion carried.

Clerk Sevcik noted that the Partisan Primary Election is August 13th and poll workers are set. There will be a public test of the polling equipment on August 6th at noon & that notice is properly posted.

Town Disbursements were discussed, approved and paid.
