First Responder Suzi Sevcik reported there were three calls this past month.

Chairman Wesely gave an update on the IOH meeting he attended.

Tisch Mills Fire Dept Contract was discussed, the contract is missing Sections for coverage so it was tabled to next month and it will be revisited by then.

Randy Polifka Small Claims Summons – After discussion, Chairman Wesely moved to bring our written response that was presented to the court date as well as the Clerk & Treasurer will appear in person. Supervisor Duckart seconded the motion.

Update Town Fees – after discussion, Chairman Wesely moved to update the following fees – Quarry to \$400, Appeals to the Zoning Board of Appeals to \$300, Class B Malt Beverage to \$50, Tobacco to \$10. Supervisor Duckart seconded the motion, motion carried. The resolution will be on next month's agenda for final approval and signatures.

Town Disbursements were discussed, approved and paid.
